Participants (Students) Should Bring:

- Eye and Ear Protection (if you have it, it will be provided if you do not)
  - Note keeping supplies (pens, pencils, paper)
  - Drinks and snacks. (Broad Street Deli is 1-½ blocks away.)
  - The **UNLOADED** handgun you intend to use for “carry” (defense, carry).\*\*
  - The holster you intend to use for “carry”.\*\*
  - 30-50 rounds of ammunition “correct” for your handgun.\*\*
- Do NOT bring any ammunition into the classroom** – leave it in the car. 30 rounds are required for qualification. Extra ammo can be used for practice and/or “proficiency drills”.

\*\* - No gun? The instructor will provide a .22 semi-automatic handgun and ammunition for your qualification if you request it. There is an additional \$10.00 fee to cover the cost of ammunition and the time for cleaning the gun. If you would like to qualify with a larger caliber the fee will be adjusted to the “market price” of the ammunition required. All arrangements for “use of instructor’s guns” must be made well in advance of the dates of the class.

All “paperwork” (registration, waivers, **payment**) must be complete before class begins.

There is **NO** age requirement/limit on the North Carolina Concealed Carry Handgun [“Approved”] training, and **NO** expiration on the certificate. You cannot *submit an application* for a Concealed Carry Handgun Permit until you are 21. This course is great for the 18-21 year olds who are interested in firearms, live in homes where handguns are present, open carry, and/or plan to get a permit when they turn 21. Because of the “adult” nature of the “purpose for concealed carry” and the “legal issues” this course is **NOT** recommended for juniors/minors (less than 18 years old).
